You can easily see the condition and dimensions in the photos. Consult the departmental archives of the Manche, you will find the use of this seal and the cases that were judged by this justice of the peace. Matrix with the Charter of 1830, it is a seal from the 19th century. It was the Constituent Assembly that established the justices of the peace in France by the law of 16 and 24 August 1790. The aim of this creation was to provide citizens with a justice system that was closer and more efficient, in parallel with traditional justice: it was the desire for a simple, rapid, free and

equitable local justice system, heir to the seigneurial justice of the Ancien Régime. In 1830, the justices of the peace and their deputies were appointed by the king, from a list of three candidates presented by the attorney general of the area. The main mission of the justices of the peace was to settle everyday disputes through a conciliatory approach: small personal and property matters, recognition of paternity, minor conflicts between individuals, disputes between neighbors, conflicts between tenants and owners (owners complaining that they had not received their rent, tenants complaining about excessive charges, for example), simple police violations, lifting or maintaining seals (during the settlement of estates in the case of inheritances). Accessible free of charge, the justice of the peace was present in each canton. Access to the position did not require any particular qualification in law or diplomas<sup>3</sup>, but resulted from a vote, then an appointment. From then on, we mainly find people with established moral authority and social status. He was also responsible for administrative tasks, in particular the presidency of various local commissions. The justice of the peace had to have common sense, be perfectly familiar with the customs in force and judge reasonably. The cases handled by the justices of the peace are now transferred to the departmental archives and can be consulted there in each department.
