Description

A green-colored cut crystal Roemer wine glass in the Tommy pattern by the Saint-Louis crystalworks, located in the Münzthal valley in the Moselle department (57) of the Lorraine region.- The Saint-Louis manufactory is the oldest in France; today, it is part of the Hermès group.- The "Tommy" pattern was created by designer and decorator Joseph Bleichner (born 1887).- He served as head of the design, decoration, and fancy-ware creation department at the Saint-Louis crystalworks.- As one of the company's principal designers and decorators--working there from 1903 to 1957--he produced a vast number of designs and decorative patterns for Saint-Louis.- His various design and decoration sketches are preserved at the Saint-Louis crystalworks museum.- From its

star-cut foot to the brilliant reflections of its diamond and bevel cuts and beaded bands, the "Tommy" pattern has been timeless since 1928; its elegant lines grace the most refined table settings.- This green-colored crystal \*Roemer\* wine glass bears the Saint-Louis stamp beneath its star-cut round foot, as well as a transparent sticker with gold lettering reading "Saint-Louis France" on the top of the foot's base.- This green-colored crystal \*Roemer\* wine glass is a vintage piece in good condition, though minor signs of use may be visible; being handmade, the glass may exhibit slight variations (in height, weight, patterns, etc.). - Far from being flaws, these differences make this Roemer wine glass a unique object.- Appreciate them for the true value of the craftsmanship involved, created by the master glassmakers at the Saint-Louis crystalworks.- Period: 20th century (from 1928 to the present day).- Reminder to buyers regarding the right of withdrawal for online sales via my Proantic shop.- Must be read before purchasing from my sales site hosted by Proantic.-- The right of withdrawal applies to sales made through my Proantic shop.- The withdrawal period is 14 days following the buyer's receipt of the item or goods.- The buyer must notify me via email or registered letter--without needing to provide a reason or justification--within the 14-day period prescribed by law, starting from the receipt of the parcel or goods.- The buyer has the right to change their mind and is entitled to a 14-day cooling-off period under this withdrawal law, and I respect this right.- Once this period has elapsed, the sale will be considered final and binding.- Return shipping costs (via postal service or carrier) are the buyer's responsibility in the event of withdrawal.- The buyer is required to return the goods or item within 14 days of receipt, in the same condition in which it was received--without breakage or damage--and in the original packaging, using the same shipping method and insurance coverage (matching the sale price on my Proantic shop) as

originally arranged by the seller; the buyer must also email me the proof of posting/drop-off receipt issued by the postal service or the shipping slip issued by the carrier. - All sales made via my Proantic site are covered by insurance purchased from La Poste at the time of shipping; this covers loss or theft up to the purchase price paid by the buyer. - La Poste does not provide insurance against breakage or damage to the item or object; shipping coverage extends only to theft and loss. - Additional insurance covering breakage or damage--up to the price paid by the buyer on my Proantic site--is always purchased from the carrier when a third-party carrier is used. - The buyer faces potential legal penalties if they fail to return the item or object within the 14-day timeframe or if it is not returned in good condition. - Refunds for the item or object will be issued within 14 days of the seller receiving the item or package and verifying the condition of the item or object. - If the item or object is found not to match its original condition at the time of dispatch, the sale will be considered final and non-refundable; the right of withdrawal will not apply. - Refunds for the item or object will be issued using the same payment method (check, bank transfer, PayPal) used by the buyer for the original purchase on my Proantic site. - If payment was made via PayPal, the buyer is responsible for initiating the refund process themselves--specifically by navigating to the "Dispute" section and opening a dispute case involving themselves, PayPal, and the seller. - This note regarding sales on my Proantic page is addressed to individuals who are litigious or acting in bad faith. - I advise such individuals against making any purchases on my Proantic page; this will prevent me from wasting time and money on legal proceedings. - Fortunately, my sales on Proantic generally go very smoothly, as my customers are typically pleasant, agreeable, and acting in good faith. - Sincerely, - Mr. Pineaud.
